Mya Rose passed away in July 2012, but in her brief lifetime she inspired support among so many whose lives she touched which continues to this day. All of this being said, the dedicated physicians and researchers such as Dr. Maris continue to need financial support for their work, and in memory of Mya Rose I will donate 25% of every mediation fee through the end of the year to Dr. Maris and his dedicated team at our own Children's Hospital of Philadelphia."
